RESOLUTION CEN/TC 278/040/13/2008 taken by CEN/TC 278 on 2008-03-14 Location of the meeting: Delft

**Subject: CEN/TC 278 – Co-operation in the field of telematics in public transport** CEN/TC 278 Road Transport and Traffic Telematics,

- noting the activities of the European Railway Agency (ERA) in defining Technical Specifications for Interoperability (TSI) in the field of Telematic Applications in Passenger transport (TAP),
- confirming that standardisation in the field of telematics for passenger transport is within the scopeof CEN/TC 278, and that WG 3 *Public Transport* of TC 278 in particular is actively developing standards in this field;
- invites the ERA, and especially the working party which is developing TAP TSI, to cooperate withCEN TC 278 WG 3;
- encourages its WG 3 to co-operate with the ERA in the development of standards;
- invites CLC TC9x and CEN/TC 224 to join eventual future standardisation work for the TAP TSI in CEN TC 278 WG3.

The decision was unanimous.

## Liaison ERA (TAP-TSI)

- Mister WAGA from ERA want these Technical Specifications Interface (TSI) for Interoperability in the field of Telematic Application for Passenger Transport (TAP) be developed even on ERA side only with UIC leaflets if it is necessary. There is a quality issue behind.
- UIC leaflets are based on centralized architecture system and extremely constraining.
- These documents have a legal impact and can have a high impact on our local PT organizations. Therefore TAP-TSI have to mandate an architecture and data dictionnary that is consistance with TRANSMODEL, IFOPT and SIRI both extend the concept in Transmodel and would be relevant to TAP TSI interest.
- We consider that is an opportunity to harmonize or to interface PT road and rail services

# Liaison ERA (TAP-TSI)
